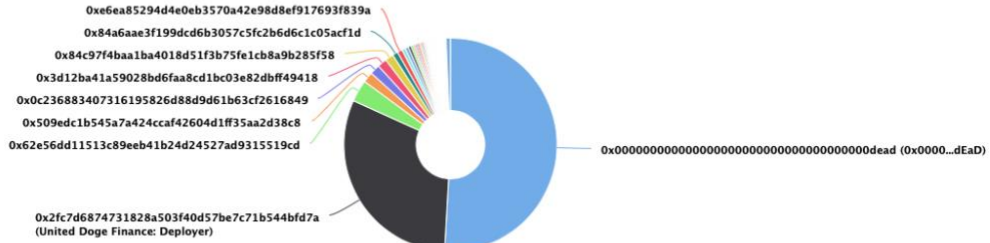

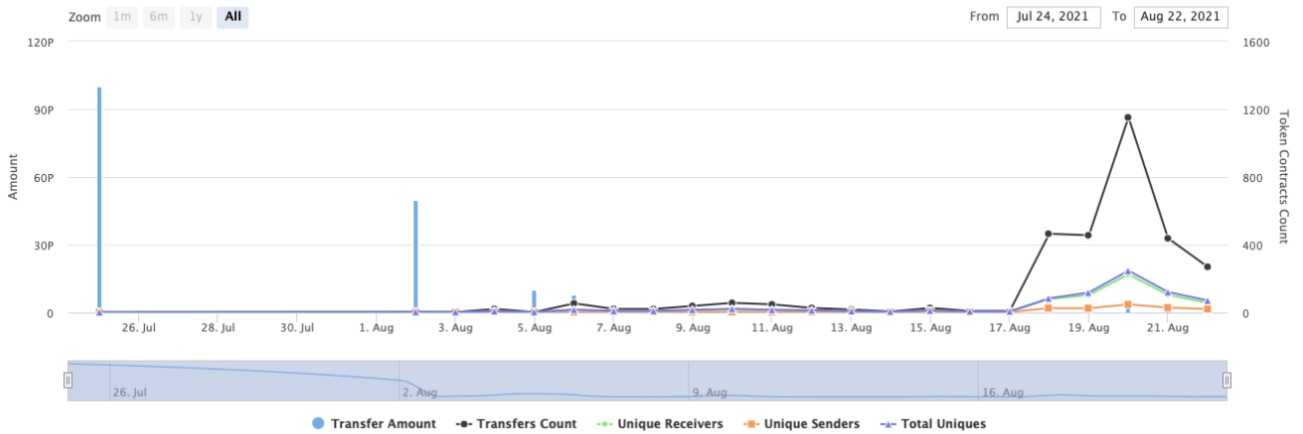

## ✓ Low Severity Issues

### 1. Out of gas

Issue:

- The function `includeAccount()` uses the loop to find and remove addresses from the `_excluded` list. Function will be aborted with `OUT_OF_GAS` exception if there will be a long excluded addresses list.

Recommendation:

Check that the excluded array length is not too big.

## Owner privileges (In the period when the owner is not renounced)

- Owner can change charity address.

Smart contracts contain low severity issues! Liquidity pair contract's security is not checked due to out of scope.
